
Everyone should have by now received their 2008 dues invoice and booklets of state raffle tickets. Please don't delay in getting these important documents back in a timely manner.

# January Gardening Tips By Mary Irene Katsibas Clemson University Master Gardener

January is still a good time for transplanting or planting trees, shrubs, roses, perennials and seeds for spring flowers. Don't wait until it gets too warm. Remember to make the planting hole 2 times the width of the container and the same depth. Trees and shrubs are a major part of any landscape and careful planning is important for choosing the best plant and location. A great deal of thought and research will pay off with good additions to your yard. You should give attention to choosing plants that have good pest resistance for this area. Euonymous, red tips, and cotoneasters are some that can cause problems. Find plants that don't require much water and can take the heat and humidity. It is very important to find out the mature size of anything you want to plant so you can choose the right spot. Many homeowners are stuck with plants that were planted too close to the house or are too big for the area where they are growing. Many plants come in dwarf varieties. Look for shrubs and trees having berries that will attract birds. Go to the consumer horticulture section of the Clemson University website for lists of trees and shrubs good for this area. Clemson.edu/ hort/HomeHort.php Or call the extension service and ask for a list to be mailed to you. 843-`722-5940 No fertilizing yet for anything except your pansies, snapdragons, and other flowers you planted in the fall. Use a fertilizer containing "nitrate nitrogen" on those. Pruning is best left until February just in case we do have a freeze. If the dry and warm weather continues, your yard will probably need a good watering at least every 10-14 days. If you haven't had a soil sample done in the past 3-5 years now is the time to do it.

Clean up fallen camellia blooms to help prevent petal blight. Give your houseplants a half turn every month so they don't grow in one direction. If you see brown edges on the leaves, mist them twice a day. Keep them out of drafty areas

If you deeply water 24 hours before a freeze hits, the moisture in the ground will hold heat and help prevent damage.
