South Carolina K of C License Plates

Brother Knights,

During the last term of office as State Deputy, Roosevelt Cummings, inquired of you at a meeting if there would be interest in obtaining license plates for the Knights of Columbus. Almost every one indicated their desire to have one of these license plates.

From that meeting a committee was formed headed up by our State Treasurer, Joe Gubeli, to put forth an effort for you to express your favor in this effort. To date only 24 knights of the 7,400 plus, have responded. The committee indicated a cut-off time limit of one year for this endeavor. It has been one year, which the state has been promoting this sale of, "South Carolina Knight of Columbus License Plates". The Worthy State Deputy has asked me to extend the deadline, until the first of March 2006. Please fill out an application for Special License Plate (See page 9) and mail it to Joseph F. Gubeli Jr. 214 Basswood Ave Summerville, SC. 29483-4450 along with a check make out to Knights of Columbus State Council.

If we do not receive a total of 400 requests for the K of C State plate, we will be forced to refund the monies to those who have paid and filled out their Form, for the South Carolina Knight of Columbus License Plate. This will conclude the thought of having, or even applying for approval of a Knights of Columbus State Plate.

Thanks to the results of our Fall Blitzes and the leadership of our District Deputies, we had a banner month of November with 63 new brothers joining us and only 2 suspended. This leaves us at 104 net new brothers year-to-date, equivalent to 31% of our annual quota. Since we are now 42% of the year complete, you can see that we still have some catching up to do. Again, due to the Fall Blitzes, prospects are very good for December and January. I'm looking forward to seeing where we stand in 30-60 days.


Although we still have 15 councils which have yet to sponsor, and an additional 4 which are running negative due to suspensions, it is especially encouraging to see many of our smaller councils, 30-50 members, moving forward with recruiting and sponsoring. New members are the very life blood of our order because they spread the work load and bring us new ideas which revitalize us. This is why every Grand Knight and council officer has an obligation to be membership conscious and follow up with his membership chairman to be sure that he and his committee are working the lists and have pro-active programs in place to increase our ranks. Even 1 new member is a cause for rejoicing, but for smaller councils especially, each new member gives us a small step forward to insure our survival and then move on to our future growth. We need to have

a line of succession, so that the same few brothers that have been providing leadership and doing all the work, get a break. Remember that every council that now has over 200 members, once started out with 30 or 40.

Please keep 3 things in mind as you look ahead to 2006. One, use your field agent, not only to help you sell insurance, but to be a vital part of your recruiting efforts. These men are all professional salesmen, in addition to being brother knights, and several have held positions of leadership at the council and state level which makes them well suited to tell your prospects why becoming a knight is an experience of a lifetime. Two, make every effort to control your losses. In the long run, make sure new members are involved and working from day one. In the short run, bring them in before you let them go, and be sure that every effort possible has been made by you and your Retention committee to save each and every delinquent. It is inevitable that we will lose some, but delinquent dues, in itself, is not sufficient reason to suspend. Make him tell you that he no longer qualifies or wishes to be a knight. And Three, be sure to plan a Spring Blitz or it's equivalent for March or early April. Results this fall offer overwhelming evidence in the value of the blitz for reaching large numbers at once and increasing our ranks dramatically in the short term. May you and your loved ones enjoy a blessed and safe Christmas season and a healthy and productive New Year as we continue our discipleship as brother knights.

Health Services Byline

"The Bugs Are Fighting Back"

Recently, the current medical literature has been reporting numerous articles concerning infectious organisms changing, evolving, mutating, and slowly adapting and becoming resistant to the usual way of treating and using antimicrobials. These infectious organisms include the classic bacterial lot, plus a whole host of large and small viruses, prions, etc. with a resulting increased morbidity and mortality. The top human killers remain tuberculosis, malaria, and schistasoma infections.

The classic signs and symptoms of infections, however, remain the same, namely, fever, redness, swelling, pain, and organ dysfunction. These signs and symptoms should signal and alert us that various organisms are causing a systemic response via what we call an infection. (An infection is further defined as bacteria and other organisms growing in normally sterile tissue).

Once it starts, timing response is the most important therapeutic variable. The earlier the diagnosis is made and treatment begins the better. Prompt early management of the source of the infection is the cornerstone of sepsis treatment.

Use your physician's experience and call for advice. He/she has a full diagnostic bag of tricks to isolate, grow, and identify the organism and to test it for sensitivity to various antimicrobials for the correct antibiotic therapy, to do surgical drainage (if necessary), to physiologically monitor the patient and to provide the appropriate ventilatory support, to use the right anti-inflammatory agents, etc.

REMEMBER: Every infection is potentially serious, so don't wait to prove the point. Use your physician's experience! LUPO.

Hopefully technical problems at Supreme will be resolved and program kits will be distributed on time for the 2006 Soccer Challenge.

The scores of the State Champions were submitted to Supreme for international competition.

Knights of Columbus Substance Abuse Poster Contest I hope all the councils planning to conduct this program have requested, and received the free kits from Supreme.

It is open to all boys and girls ages 8 to 14. Competition is in one of two categories (alcohol or drug abuse) and two age groups (8-11 or 12-14). Each council can then have as many as four winners. The winning council posters and properly completed entry forms must be in my hands by February 1, 2006. There will be no District judging. A panel of judges will select the State Council winners at the Mid-year Organization meeting February 4, 2006.

Small cash awards may be given to poster contest winners at the council level. The state winners will receive plaques and \$50 checks. Their posters are submitted to Supreme for international competition.

Knights of Columbus Free Throw Championship Order our free kits from Supreme for this program. It is open to all boys and girls ages 10 to 14. Councils can then send 10 winners to District Championships. Council championships should be in January. District competitions will be in February.

The properly completed entry forms of each District winner, showing both council and district scores must be in my hands by March 15, 2006. The State Council Free Throw Championships will be hosted by Columbia Council 12554 at St. Joseph's Catholic School starting at 10:00 AM Saturday March 18,2006.

Cash awards should not be given to winners of this program. District winners will receive medals available from Supreme. District Deputies must request these medal. State Council winners will receive trophies. The scores of the winners at the State Championships will be submitted to Supreme for international competition.

Seventh Medical Organization Affirms Abortion-Breast



Cancer Link. According to a December 7, 2005 LifeNews.com article, "MaterCare International, an international group of OBGYNs, has become the seventh medical organization to affirm the link between abortion and breast cancer. The organization says it's

disappointed that groups like the National Cancer Institute has misled women about the research on the subject. Dr. R. L. Walley, an Obstetrics and Gynecology research professor, said MaterCare was first presented with information about the link at its October 2004 conference. 'The medical explanation and the epidemiological evidence convinced our group that there is a significant increase in breast cancer risk after induced abortion, especially before the first full term pregnancy,' Walley explained.

Dr. Walley said some studies have been conducted in an effort to cast doubt on the link, which has been found in most research conducted on abortion's link to breast cancer. Those studies 'have serious methodological weaknesses and flaws and therefore do not invalidate the conclusion that there is an increased risk of breast cancer,' he explained.

Walley said his group is concerned that women are not being informed by abortion centers before they have abortions that breast cancer is a real possibility following an abortion. 'This evidence has been denied by the U.S. National Cancer Institute (NCI) and other researchers,' he explained. 'Women have a basic right to know of this increased risk of breast cancer and it is unacceptable that the information should be denied to them by the medical and cancer research establishments,' he said."
