tion from the Insurance Marketplace Standards Association for ethical business practices.

In its 2006 report, Standard & Poor's singles out the Knights of Columbus's "strong capital," and its "very strong" competitive position and liquidity. From the Membership Director

We had an outside chance of making quota for the year on June 1st, but sadly we spun our wheels this last month, adding 37, but losing 33, as a number of councils, which had room or couldn't make it, cleared their "deadwood". In total, against a quota of 324, we brought in an acceptable 463. Unfortunately, we lost 185, still far too many, and wound up with a net gain of 278, 46 short of goal, about 86%. As you can see, it would not have taken much to have made it this year. We can still do better in recruiting, but we still have a lot to learn about keeping what we have. Each council, especially the larger and fastest growing, need to put into action pro-active retention programs including more personal communication, so that we know where all our "inactive" brothers are, both physically and mentally with respect to their membership. Please continue to heed the words of our Retention Chairman, DD Mike Mika, and commit to reducing losses in '06-'07.

22 of our councils achieved at least 100% net this year and 17 of those also attained 100% or more insurance quota, thus meeting all membership requirements for STAR council. Congratulations to the 17! But 17 out of 58 is not quite 30%. Most of these councils simply made a decision and saw it through, measuring progress against goal, monthly, and stepping it up when necessary. I have maintained that we should have 70% or more make STAR. How many of the 41 of you remaining will make the commitment and break through in '06-'07? The decisions you are making right now, this month, will tell whether


that's going to happen.

Our 22 achieving councils netted 260 of our additions this year, an average of 12 new brothers per council. Top 10 leaders in order were: #2207 Sumter-337.5%(they brought in 7 new brothers in June for a total of 27 for the year), #7531-Conway-266.6% (last year's leader, also finishing strong with 3 additions in June), #12263-Bluffton-242.8%, #6900-Charleston and #13713-Blythewood-220%, #9575-Spartanburg-212.5% (a perennial leader), #11910-Summerville-200% (a frequent leader), #10819-Simpsonville-150% (another regular), #7129-Greenwood-140%, and #6847-E. Columbia-137.5% (another consistent achiever). Two other councils are especially worthy of mention because they never gave up, and qualified for STAR by each bringing in 4 new brothers in June. They are #5026-Beaufort and #8502-Walterboro. On the insurance side, 18 councils made quota, led by #5026 Beaufort-266.5%, #7531-Conway-233.3%, and #6847-E. Columbia-200%. Use your Insurance Agents in recruiting too!

Worthy fellow leaders, let us not wait for October or November to get started. Go away from your District kick-off meetings this month, with a new sense of purpose and a total commitment to do it again this year if you made it in '05-'06 and to break through with pride if you missed it. Appoint a gogetter as Membership Chairman and go for it!

I look forward to speaking with you at the new Grand Knights' Orientation on the 23rd. Bring your Membership Chairman. Know that I can be reached at CAV62489@aol.com. I welcome your input and calls for assistance throughout the year. Vivat Jesus! Jack Cavagnaro, PGK, PFN, State Membership Chairman

Health Services Byline

T "Medical Health Insurance, Part III Problems, Myths, and Suggested Solutions"

Originally, we looked at the current issues involving medical health insurance and last month we examined the players, the employers and the physicians in this three sided box. This month we will try to pinpoint problems, myths, and suggest solutions.

One of the major problems is that health care consumers do not understand medicine nor do they know the costs involved per medical issue. Ultimately, monies must be set aside to pay for health care for the system to work, by someone. If your employer has an insurance plan, it is a good start. The concept of a Health Care Savings Account is actually a very good one especially if it is tax free. If you have such coverage, KEEP IT!

Another functional problem is that medicine evolves slowly and updating is a slow process and as such is costly and inefficient. Computerization of medical records, prescriptions, legal reforms of historical documentation requirements could go a long way to help with costs.

We create costly problems with health care by not encouraging known and well established preventive medicine items. A healthy life style not only improves our very lives but it can significantly decrease associated care costs.

Suggested legal reforms include for example capping lawsuits and capping jury awards, lowering health care tax deduction thresholds, use physician state wide boards to determine medical legal liability compensation issues (malpractice reform), increase the formation of medical associations for the purpose of group purchasing to drive down medication costs etc., support physician use of generic drugs, and allow medical state boards to act against medical fraud cases.

The right Health Insurance for you would not be too expensive in the long run if issues like the above list would be put in action. You with your medical care insurance should be able to be protected from catastrophic medical expenses and still be able to have access to your primary care physician, specialists and care facility.

There is also a long list of other benefits that might be considered i.e. periodic exams, dental care, eye care, hearing aids, OB/GYN care etc.

REMEMBER: You are the real bottom line and for the most part you can afford or should be able to afford good care. Be intelligent and involved with your health care questions. LUPO

Spartanburg Council's Seminarian Writes on the Influence of the Laity

The following article was written by seminarian Richard DeClue, Jr., and he has given permission to submit the article for publication. Deacon Rick is one of the three seminarians our council is helping through the Knights of Columbus Refund Support Vocation Program.

The Influence of the Lay Faithful in My Vocation

In reflecting upon my life, I can see the laity influencing my vocation every step of the way. I would like to share how the laity has impacted my vocation in its various ways.

First, no clergyman is ordained from birth. Before they were ordained, priests and deacons were members of the lay faithful, who by virtue of their baptism already participated in the priestly, prophetic, and kingly



roles of Christ within the world, even if they now participate as priests, prophets, and kings in a new and essentially different way. It takes many years after ordination to be clergy as long as one was a layman.

It is often the case that the way we were as laymen has a tremendous impact on the way we are as clergy. How we think, live, and pray now have their foundations in the way we thought, lived, and prayed as lay men, even if there are drastic changes that have taken place since ordination.

In my own case, the experience of lay ministry was integral to my discernment process. The more my friends and I shared our faith through prayer and deep discussion, and the more I was involved in lay ministry, the greater my draw towards the priesthood became. Still further, it was other lay people who knew my vocation before I did. Friends, family, and at least one stranger all suggested the priesthood to me before I saw it for myself. I used to get frustrated when others would suggest it to me. After some years, I came to find out that they were right. My grandfather, after I told him I was going to seminary, responded by saying, "I saw it coming 12 years ago!" It is clear to me that God used lay people to reveal His call to me, and I am forever grateful to them for their encouragement.

The lay faithful were also a part of my discernment process in another profound way. This manner of influence, which originates in God's own love, can best be summarized in the words of Psalm 16: "He has put into my heart a marvelous love for the faithful ones who dwell in his land." Fundamentally, it

was the love of God's people that motivated me to discern a vocation to the priesthood. I was filled with the desire for their salvation, and I wanted to be an instrument of Christ in helping to bring God's grace to them so that they might become holy.

This manner of influence remains a key element in my ministry as a deacon. During a very fruitful conversation with a fellow seminarian, I came to the realization that it is often my desire for the salvation of others that reminds me of—and fuels my movement towards—my own holiness of life. In other words, I care more about the state of my own soul the more I recognize the impact it has on the people to whom I minister.

My new task of proclaiming the Gospel and preaching the Word of God calls me to spend more time delving into the wealth of wisdom supplied in Sacred Scripture. I find that as I preach, I am also one of those listening and learning. Again, it is my desire to have something valuable to say to the people of God that motivates me to learn and to grow in my understanding of Holy Scripture.

My experience of prayer has also changed. Before ordination to the diaconate, we promise to pray "with and for the people of God." This manifests itself in very personal ways. In my daily ministry, I come in contact with parishioners' various needs, struggles, and joys. These encounters shape my experience of prayer. An example could be the words from the *Salve Regina* that cry out "...to you do we cry, poor banished children of Eve." If one sees a parishioner breaking down in tears over a struggle of faith or the loss of a loved one, the next time one recites the *Salve*, this image may come to mind. Of course, my family played crucial role in my vocation. It was through family prayer that developed the habit of private prayer. My parents instilled in me a love for the truth of our Catholic faith, and it was within this environment that the seeds of my vocation grew.

Finally, the tremendous support and encouragement of the laity reinvigorates my ministry and strengthens my sense of the call. Several times during my current summer assignment, the delightful people of God have shared their appreciation for what I do. They have encouraged me to continue on my path towards the priesthood with such words as "we need you" and "you will be a great priest." Such sentiments fuel the flames of my desire for the priesthood and remind me of the very purpose for which I have been called: to be with the people of God along our mutual journey towards sanctity, so that we may forever give glory to God as members of the Communion of Saints in Heaven!
