## Supreme Knight, Board Urge Support for 'Bella'

Supreme Knight Carl A. Anderson, with the backing of the Order's Board of Directors, is recommending that Knights support *Bella*, a major motion picture to be released this summer.*Bella*, whose star and producers are Knights, won the Toronto Film Festival's People's Choice Award."If we can get millions of people to see this film, we are going to save lives," Anderson said. "We can get people to understand what we mean when we talk about a culture of life, or what it means to live a Catholic life. Our support of this movie can be the start of something great."In particular, councils are asked to <u>conduct private screenings</u> of the film a week before its release to the public on Aug. 15 in Texas and throughout the U.S. in September.

To reserve a movie theater and receive a marketing tool kit, Knights should call 888-474-6025. An average-size theater of 300 seats in most major markets rents for \$3,000; tickets will be sold to councils for no more than \$12 each. Because the film has a strong pro-life theme, Anderson said, councils could consider screening the movie and donating any proceeds to local pregnancy resource centers. Bella was produced by Knights Leo Severino and Sean Wolfington, and stars Knight Eduardo Verastegui. Verastegui and Wolfington took their First Degree in New Haven at the June State Deputies meeting. The state deputies and their wives also enjoyed a premiere showing of Bella. The movie tells the story of Jose (Verástegui), who gives up his career as a soccer superstar after a tragic incident.He goes to work in his brother's restaurant, where he befriends a pregnant waitress and begins to resolve some of the pain he stills feel about the life-changing accident. A former telenovela (soap opera) star in his native Mexico, Verástegui abandoned his burgeoning Hollywood career to start a new film company to produce movies with a moral message. After the screening, Verástegui spoke briefly to the Knights. He described his character as a "man who wants to live a life of integrity and sacrifice everything" for family and others. The film does this by portraying Latinos and family life in a favorable light.

Hurrah! We did it! For the first time in 6 years South Carolina made it's membership quota. We needed to gain 344 and we gained 353. Congratulations to all of you who were a part of this success!

30 of our 59 councils qualified for the Fr. McGiveney Award for 100% net membership gain. Our leaders were: 6900-The Citadel- 640% (almost 10% of our total gain), 7122-N. Myrtle Beach-275%, 12263-Bluffton-244.4%, 6847-E. Columbia-233.3%, 6892-Irmo and 12472-Charleston-220%, 11910-Summerville-216.5%, and 5194-Florence-200%.


A strong finish on the Insurance side enabled 19 of our councils to make the Founders' Award and 19 in total qualify for STAR COUNCIL. Unfortunately, 4 councils fell one insurance member short of otherwise making STAR.

Our STARS are: 5194-Florence, 6076-Spartanburg, 6250-Charleston, 6629-Summerville, 6847-E. Columbia, 6884-Seneca, 7122-N. Myrtle Beach, 7289-Hilton Head, 9184-Taylors, 9475-Mt. Pleasant, 9575-Spartanburg, 9576-Pickens, 10668-HiltonHead (9 in a row), 11910-Summerville, 11991-Goose Creek, 12274-Greer, 12472-Charleston, 12554-Columbia, and 13112-Greenville. I hope you'll all party when you hang your plaques!

Sadly there were 9 councils that did not sponsor a single new member and another 6 that had more losses than gains. For you 15 and the 14 others who fell short, my question is simple. What will you do differently this year? The Fr.McGiveney and Star Council awards are goals you have to believe you can achieve and then dedicate and commit your councils to follow up and make it happen. For some of you it starts with sponsoring just one.

On July 28th we will meet in E. Columbia for the new Grand Knights' orientation. I ask every council to attend and I challenge each one of you to come with a plan for doing 100% net new membership increase and 100% net insurance member increase for '07-'08. If any Grand Knight needs further help with this, please see me at the end of the session so we can put an individual plan together to move forward. South Carolina can do 125% or more this year!

Again, congratulations and thanks to each of you who contributed to our collective achievements this past year! Vivat Jesus!

## **Patriot's Corner**

In my last article some Sir Knights were offended by a statement made.

An editorial is only an opinion of the writer. Nothing stated was to offend anyone, just plain facts.

It is interesting to know someone out there is reading the newsletter. Thank you for your comments.

At this sentence, I yield to the Supreme Master and Vice Supreme Master. From "Frank Scandone", Date 05-06-2007 Subject: Wearing of the Flag

Dear worthy Sir Knight Fitzsimons:

The Supreme Fourth Degree office asked me to reply to your email to the Supreme Knight Carl Anderson about the wearing of the flag on tuxedo lapels.

The Supreme Master Joseph Schultz in the Memorandum dated, May 23, 2005 to all Vice Supreme Masters, District Masters and Faithful Navigators addresses the issue you have inquired about. I will answer your question quoting from this memorandum, in case you were not briefed by your assembly or district officers.

1. A "Pins: The plain, unadorned Fourth Degree pin (of the style approved by the Supreme Council for new members) may be worn on the left lapel of the jacket. The only other pin authorized to be worn is a small pin of a size comparable to the Fourth Degree pin depicting the wearer's national flag. The flag pin will be worn above the pin of the Order." The above statement authorizes the type and size of both Fourth Degree and Flag pins worn on the left side of the tuxedo lapel. Now I am going to refer to paragraph 3 for the requirements when wearing the Color Corps Regalia.

2. "Members of the Color Corps must strive for the ultimate in uniform appearance. As an example, if a pin is worn, all members in that Color Corp wear the pin; if some are missing pins then none should wear a pin. Uniformity in appearance is paramount. The official dress for those serving in the Color Corps is the same as the official dress for members with the following additions.'

This memorandum instructs all to have the same type of pins when dressed out for Color Corps participation. If some sir knights in the Color Corps do not all have pins or they are not the same, then all must remove any pins from the lapel. This is why the district master had all sir knights to remove their flag pins. The key here is that sir knights dressed are on show and must give the Order a positive imagine. In last years Supreme Convention, I had all Color Corps members remove all pins from lapels, as some had different types of flags and Fourth Degree pins. We conducted inspections before convention ceremonies of Color corps Honor Guard to ensure that all conformed to the Color Corps Drill Manual and the Memorandum on Fourth Degree Guidelines. This included the removal of sir knights that had unauthorized patches and/ or faded colors.

I do not know if you attended the Supreme Convention last year, but the 100 or so sir knights dressed out looked sharp and received positive remarks from both the clergy and supreme officers on their appearance.

## Health Services Byline

#### "Revisiting Cough Part II"

Last month we began our revisit to this protective reflex which keeps our tracheal and bronchial passageways clear from any secretions and or foreign body obstructions. From the duration of the symptom we divided cough into acute (< 8 weeks) and chronic (> 8 weeks).

With such coughing, you the patient, should note if this cough is productive or not of any sputa and should note its physical appearance, i.e. watery, thickness, color, etc. Other symptoms should also be noted i.e. concurrent fever, GERD symptoms etc.

You usually cannot fully help yourself once you have reached the chronic stage. You will need the diagnostic assistance of a professional medical person, your physician to review your interim medical history and sort out details suggesting evidence of congestive heart failure, infection, GERD etc. He/ she will also do a through physical and help order the appropriate X rays, consultations, and lab studies to rule in or out specific diagnoses. Again, the most common reasons include post nasal drip syndrome, post infection state with various viruses, pertussis, bacterial sinusitis, coexisting asthma, GERD, various forms of bronchitis, and the use of specific medications.

Treatment includes symptomatic treatment and treatment for a specific suggested etiologic process and watching for results. Additionally, other more invasive X rays, fibro –optic and immunologic studies may need to be done.

Some time in the future we will visit some of the above in Cough III and IV.

## Catholic Information Service Director Appointed

Dominican Father Juan-Diego Brunetta has been appointed director of the Catholic Information Service. Supreme Knight Carl A. Anderson announced July 9 that Father Juan-Diego Brunetta, O.P., has been appointed director of the Knights of Columbus Catholic Information Service.Father Brunetta, 41, was ordained in 2001, and holds a doctorate in canon law from The Catholic University of America. He also holds a bachelor's degree in biology from St. Joseph University in Philadelphia and a master's degree in religious studies from Providence College.He succeeds Father Gabriel O'Donnell, O.P., who became Vice President and Academic Dean at the Dominican House of Studies in Washington, D.C. earlier this year. Father O'Donnell will remain the postulator for the cause for sainthood of Father Michael J. McGivney, the founder of the Knights of Columbus."I'm very excited about working at CIS," Father Brunetta said. "It's perfectly positioned to respond to the late Holy Father John Paul II's invitation to engage in a new evangelization. It's a special pleasure to build on the work of Father O'Donnell, Father John Farren and the other wonderful priests who have headed this program over the years."Father Brunetta is a Third Degree Knight, and for the past three years has served as associate state chaplain of the Connecticut State Council. He also served as chaplain to Catholic University of America Council 9542 while he was completing his doctoral studies at CUA. He is the oldest of four brothers, and was born in Vineland, N.J. His father recently retired as chief of police there, after 43 years in law enforcement.Supreme Knight Anderson said that "the Order is very fortunate indeed to have Father Brunetta join us as head of the Catholic Information Service. He brings a wealth of knowledge, faith and enthusiasm to the program, and I know that Knights and Catholics generally will be much more able to understand and to promote their faith in the years to come because of his efforts."

## From the Desk of the State Historian

This is second in the series on Chaplains and Faithful Friars who have served for 25 plus years of service.

Rt Rev George Lewis Smith was the Charter Chaplain of Aiken Council 3684 and served for 33 years and Charter Faithful Friar of the Aiken Assembly Fourth Degree for 25 years. He also served as the State Chaplain and Fourth Degree SC District Friar.

The Rev Monsignor George Lewis Smith was born and raised in South River, NJ. As a young man he was a successful lawyer for Smith and Dickerson, Counselors at law in New Jersey. During this time, George Lewis Smith became an active member the Knights of Columbus and served as State Secretary.

In his mid 30's, recognizing a call to the priesthood, he entered the seminary in Rome. He was ordained on March 13, 1937 by Cardinal Marchetti Selvagianni, the Vicar General of Pope Pius XI, at the Basilica of St John Lateran, in Rome.

Father Smith arrived at St. Mary Help of Christians Church in Aiken in 1938 and became the Pastor a year later. At that time, Catholics comprised less than 2% of the state and prejudices against Catholics was prevalent. He worked diligently for the church, making many physical improvements to St. Mary's Church. He also established Aiken Missions, which included establishing churches in the Horse Creek Valley area (now Our Lady of the Valley) North Augusta (now Our Lady of Peace), and New Ellenton. He also started the Horse Creek Valley Welfare Center.

In August 1948 he was elevated to the rank of Domestic Prelate and known as Rt Rev Monsignor. He continued as Pastor of St Mary's until his retirement in 1972.

During his service to the Diocese of Charleston, he served as Auditor of the Diocesan Tribunal, Pro-Synod Judge, and a Director of Hospitals for the Diocese of Charleston. He also served as Vice President of the American Hospital Association, President of the South Carolina State Hospital Association, President of the Catholic Hospital Association and member of the National Blue Cross Commission. He served as a member of the Advisory Committee to the Hospital Division of the National Resources and Planning Board in Washington DC during WW II. He was also appointed as a Consultant of the Pan American Sanitary Board and as a member of the faculty of International Institute in Hospital Administration. On July 19, 1953, Msgr Smith became the Charter Chaplain of the Bishop Ignatius A. Reynolds Council 3684 of the Knights of Columbus. He served in that capacity until he became ill and moved to New Jersey to be with his family in 1985. Msgr Smith also served as the Charter Faithful Friar

of Bishop Reynolds Assembly in Aiken from 1960 until 1985. He also served as State Chaplain, South Carolina State Council, Knights of Columbus and second District Faithful Friar of the SC District, Fourth Degree.

The Rt. Rev. Monsignor George Lewis Smith died in 1987. Upon his passing the Aiken Council and Assembly were renamed for him, a most fitting tribute to a beloved Knight, he was A MAN OF GOD, A TEACHER, A BROTHER, AND A FRIEND.

# Laws aim to be sure flags made in USA

ROSEMOUNT, MINN. — What's red, white and blue and made in China? A move is on in state leg-islatures to ensure that the flags folks will be flying and buying this Independence Day were made on this fruited plain.

Minnesota has passed the stron-gest measure, a new law that goes into effect at year's end requiring every Old Glory sold in state stores to be domestically produced. Vio-lations are a misdemeanor, pun-ishable by up to a \$1,000 fine and 90 days in jail.

In Arizona, schools and public colleges were required starting Sunday to outfit every classroom from junior high up with a made-in-the-USA flag. Tennessee re-quires all U.S. flags bought via state contract to be made here, and

similar bills are moving forward in New Jersey and Pennsylvania.

Most of the major domestic flag makers are privately held compa- nies that don't release their sales figures, so it's difficult to gauge the inroads being made by foreign manufacturers.

The U.S. Census bureau esti-mates that \$5.3 million worth of U.S. flags were imported from other countries in 2006, mostly from China.

To help consumers identify the origin of their flags, the Flag Man- ufacturers Association of America created a certification program two years ago that bestows a seal- of-approval logo on flags made with domestic fibers and labor.

Whether Minnesota's law vio-ates international trade agreements — and whether anything would be done about it — is an open question.
