Hurricane Relief Tops Charitable Initiatives in 2005

Led by a massive response to the hurricanes that devastated the southern United States, the Knights of Columbus announced today that it set new records for charitable giving and volunteer service hours in 2005.

The results of the Order's annual Survey of Fraternal Activity for the year ending Dec. 31, 2005, show that total contributions to charity at all levels reached \$139,711,619 – exceeding the previous year's total by nearly \$4 million. The figure includes \$33,638,426 donated by the Supreme Council, \$12,685,401 given by state councils, and \$93,387,792 in charitable donations from local councils, Fourth Degree assemblies, and Squire circles.

The survey also shows that the reported number of volunteer hours by Knights for charitable causes grew to 64,039,706 hours, up nearly 1 million hours from 2004. Additionally, members contributed another 8.5 million hours to fraternal service activity. There were 399,264 Knights of Columbus blood donors during the year, and Knights made more than 5.4 million visits to the sick and bereaved.

Many of the monetary donations and hours of service were in support of relief efforts along the Gulf Coast in the wake of Hurricanes Katrina and Rita. The Knights response to the tragic storms was swift and significant. Disbursements of an initial \$2.5 million allocation for storm relief began two days after Hurricane Katrina struck New Orleans, and a dollar-for-dollar match was established for donations provided by its members.

Knights from across the United States and Canada traveled to the storm-damaged region to assist in clean-up and recovery initiatives. Local councils also provided meals and the use of their facilities to rescue crews and victims in the weeks following the hurricanes.

Cumulative figures show that during the past decade, the Knights of Columbus has donated more than \$1.208 billion to charity, and provided in excess of 574 million hours of volunteer service in support of charitable causes.

Congratulations to all Grand Knights and Membership Chairmen who qualified for State Deputy Ray's golf shirt promo-

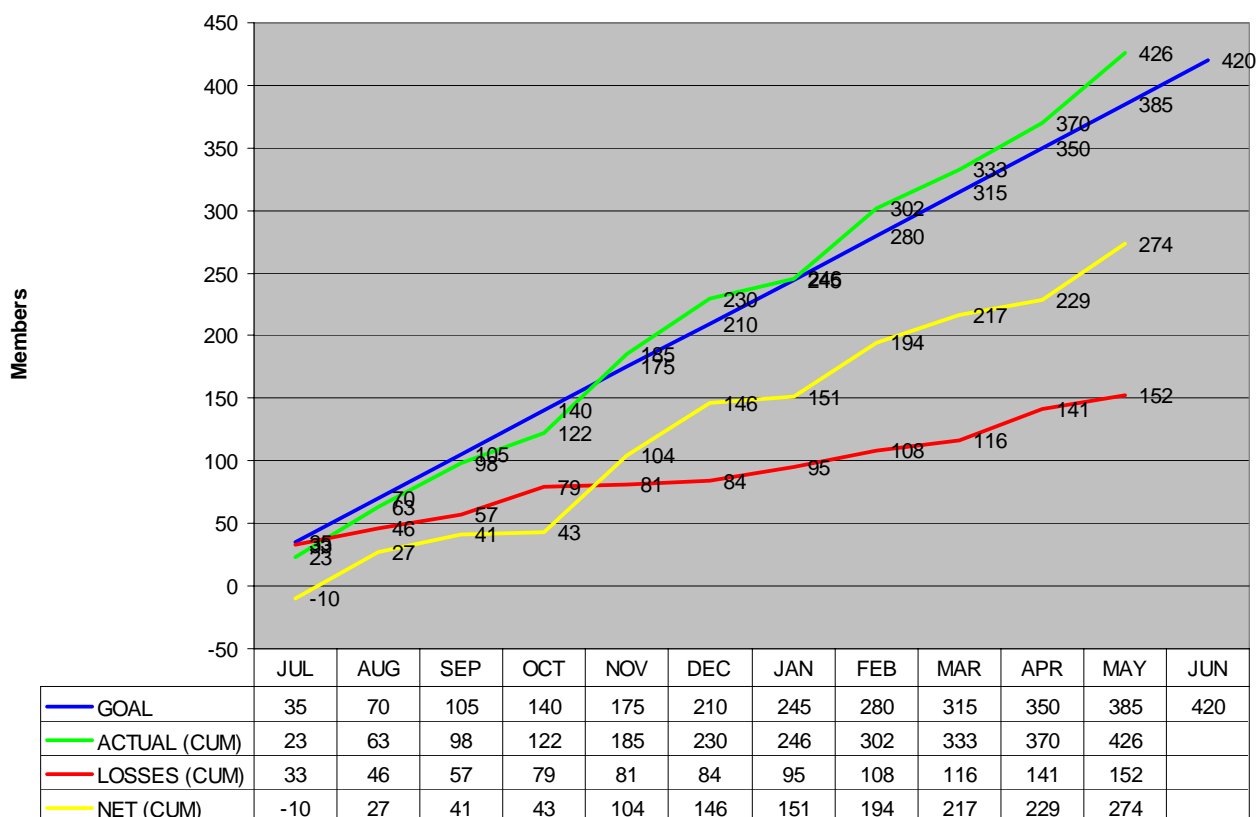

“Medical Health Insurance Part II.

**The Players, Insurers, Employers, and the
Physicians”**

Last month we breached or rather defined “the issue” with medical health insurance and problems with increasing health care costs. We will now look at the health care players more in depth and finally next month some probably intelligent suggestions etc. to help with the increasing cost and frustrations. From a health insurance point of view (the users of the system) we believe that they finally understand that the HMO's of the 80s and 90s were a failure because they not only did not improve Medicine but they restricted health care access (to physicians, to hospitals, and to specific testing) despite increasing costs and increasing deductibles.

Because insurance rates have been out of control and business profits have been so variable, large and small employers are feeling the economic pinch and they are looking for a way to avoid giving health care benefits to their employees.

For physicians, the malpractice liability issue where average jury awards range from one half to one million dollars, this is a top issue. This issue alone, accounts for markedly increased costs especially in the high risk specialties i.e. Orthopedics, OB/GYN, and Anesthesia and is causing physicians to relocate or close their practices which is already beginning to cause geographic doctor shortages. Doctors cannot do everything for their patients on a 15 minute per patient time schedule.

Are there any answers to some of these problems? Of course there are and next month we will try on some suggestions for size.

REMEMBER: Everyone benefits from reducing medical costs. Think about it! See you all next month.

It must be signed by the Faithful Navigator and submitted to the Supreme Council Department of Fraternal Services by June 30, 2006. The award application may be electronically filed and a copy must be sent to the Master and Vice Supreme Master.

The second thing is "To Be a Patriot Award." In order to qualify for this each assembly should submit form # TBP2 also found in the assembly report forms booklet on on-line at www.KofC.org. This has to be submitted to the Master of the District by June 30, 2006. The assembly should pick the best patriotic activity conducted during the fraternal year. Supporting material, i.e., photographs, news paper articles, must also accompany this application. Upon receipt of all entries the Master will form a committee to determine the winner. The District award winner will then be submitted to the Vice Supreme Master who will select a winner for the DeSoto Province; this winner will be submitted to Supreme.

Dear Brother Knights,

Ignorance is an expensive commodity. We have discovered this axiom quite some time ago and have repeatedly seen it to be a very true statement. People who “don’t know” consistently miss out on many opportunities to further their exploration in “the game of life”. Remember the parable where the servant took his master’s money and buried it in the ground, for fear he would lose it. The master chastised him saying, “at least you could have invested it to earn interest!” The implication here is that an interest bearing investment was the least that the servant should have done. In other words, he should have invested it in a way that an attractive return would have been rendered. When people don’t know how to better themselves, they usually do nothing (rather than experiment or search for better ways to live their lives). It’s called, hibernation. Another way that ignorance “costs” us betterment is when we have no clue that what we are doing is inferior or is robbing us of an opportunity to excel. We are oblivious to our opportunities lost.

This concept that we are speaking of can be applied to business ventures, home economics, education, sociology, health management, legal matters, leisure expenditures, the list is endless. But let’s get to an area where ignorance can be deadly; that is, ignorance of our Catholic faith, ignorance of God’s Will for each of us. Spiritual ignorance could cost us dearly. Fortunately (and gloriously) we have God’s Mercy to help us with our shortfalls, but Jesus clearly challenged us to exert ourselves to the best of our ability to know and learn more about our Catholic faith. Please do not be offended by our use of the word ignorance. Unless one’s name is spelled G-O-D, we are ALL ignorant to one degree or another. The key is, are we trying to learn more about our Catholic faith? Do we even care?

We have been trying for the last two years to write newsletter articles which have expanded everyone’s knowledge of an issue held closely to God’s Heart....the issue of life. God’s greatest gift to us was that of life.....our personal life, the life of Jesus, and His bread of Life. Respect for all life is imperative and we need to know about the threats to it. The fight will not end until we all stomp out our ignorance’s with the Light of Christ. Logically, that time will not occur until we make a commitment. Our commitment must be to study the faith and decide to follow it with our daily actions and decisions. The number one priority must be to live our Catholic Faith with gusto and honesty. Our Catholic moral conscience will many times lead us to donate our charitable contributions in ways that will defend life. It will be a sacrifice, or it will be not enough. The early Christians fulfilled their commitment to God in ways that cost them their lives.
