State Convention elects Ficco

NORTH CHARLESTON – The election of Robert W. Ficco as the new state deputy for the jurisdiction of South Carolina highlighted the 85th annual state convention of the Knights of Columbus on May 5 -7. Convention delegates voted for Ficco to succeed Raymond W. Hock, who served as the top Knight for the past two years. The change of leadership officially occurs on July 1.

Ronnie Ficco, Ficco's wife of 47 years, said that she was "thrilled" with the election but nervous over the amount of time it will take to perform the duties of the office. The SD-elect agreed it will be a lot of work.



"And a lot of anguish," Bob Ficco said. "But I'm going to surround myself with good people to help me make the right decisions. There will be no shooting from the hip."

Ficco alluded to the most popular part of the convention, the disbursing of funds, when he said that the impact of the state K of C councils is all out of proportion to the percentage of Catholics in SC. Operation HOPE alone has given away more than \$1.8 million in its eight years of existence.

Hock presented \$10, 000 to Bishop Robert J. Baker to spend at his discretion and gave another \$5,000 raised in the Pennies For Heaven project for diocesan seminarians. Richard Koehler gave the bishop \$5,300 raised by the fourth degree assembly.

The Knights in South Carolina also contributed \$36,000 for Katrina Relief efforts and raised \$291,000 for Operation HOPE, a new record. All the HOPE

During April we had a good recruiting month carrying over from the Spring blitz. We brought in 37 new brothers. Unfortunately, we lost 25, with one council dropping 10 and another 8. Our net gain of 12 puts us at 229 net additions year to date, which is 68% of our quota. We can still make 100%, but it will take a couple of months like last November, when we brought in 63 and lost only 2. Let's make a strong final push to make it happen!

We have 15 councils which have already qualified for the 100 Club and the green golf shirts that will go with it. There are 3 more that are "on target" and at least another 5 that have a real chance with a strong finish.

carrying us along.


We still have many prospect cards from our recent blitz. I ask you to make it Priority #1 to get all of these possible to their 1st degrees before year-end. Bear in mind that it is never too late to have a 1st degree, but you need to follow-up on new Form 100s and insurance applications at this time of year to make sure they are registered with Supreme by June 30th.

Remember also, that how we bring new brothers in is directly related to our Retention long term. Each recruit should be motivated to "hit the ground running" from Day 1. His attendance at the first few meetings should be monitored and he should be given an immediate task on a committee planning an upcoming event. He should be encouraged to go for the Shining Armor Award and his progress toward that goal checked regularly during his first year.

The legacy you give your council by getting the Star Council Award is priceless. One leads to another and it becomes a matter of pride not to break the string. So, let all outgoing leaders give it their all now, so that there can be no regrets and you can celebrate with your brothers this summer.

Health Services Byline

"Medical Health Insurance - Fact or Fiction Part I (The Issue)"

This is the first of three or four monthly articles that will cover the above stated issue. Millions of Americans think that they have insurance coverage and that they don't fall into the category of the underinsured or frankly no insurance.

Health insurance in the United States is caught in an ever changing triangle with the insurance companies progressively increasing costs and decreasing specific coverages; doctors who cannot keep up with personal malpractice insurance premiums and the paperwork demanded by the insurance companies to make sure that their patients qualify for specific needed tests and modern expensive treatments; and employers who are increasingly shifting health costs to their employees.

We, obviously have now reached or rather have backed ourselves into a fiscal corner and many middle class Americans patients face either financial ruin or do without the more complex modern care they might need.

Truly, the very poor patients are usually fiscally covered and the very rich are covered by definition but the average patient could be hit very hard by a catastrophic medical bill etc.

Next month we'll examine the dilemma from the perspective of the insurer, the employer, and the physician.

Civic Award

Last year only 369 assemblies received the Civic Award, with 2, 631 assemblies in the

order, this represent only 14% of our assemblies participating over all. South Carolina represents 3.8% of that figure. This was far below the order wide average.

June 30, 2006 is almost upon us and each assembly must conduct and report at least four varied patriotic programs held within the fraternal year to the department of Fraternal Services using the Civic Award application found in the Fourth Degree Forms Booklet. There is no reason why every assembly should not be able to qualify for this award.

To Be a Patriot

What was your assembly's best patriotic program conducted this fraternal year? Each assembly should submit a report on their single best patriotic activity to the Master on #TBP-2 entry form found in the forms booklet no later than June 30, 2006. From all entry forms the best entry shall be selected by a committee (judges) appointed by the Master. That winner (South Carolina District Winner) will be submitted to the Vice Supreme Master who will pick a winner for the Province and submit it to Supreme. Every assembly has a winning patriotic event, so submit you entry by the deadline on June 30, 2006.

Essay and Catholicity Award

Award nominations are due now; please submit your assemblies' nomination and write up to Ron Snyder now if you haven't done so yet.

monies go to benefit mentally retarded citizens and chair Michael Telesco gave away the state council's 20 percent of that fund at the convention. Many councils were recognized for raising more than their allotment for HOPE, topped by Seneca (#6884), whose members raised 414% (\$30,540).

Besides money, people were the big attraction at the convention. The convention honoree was William R. Zimmerman, a military veteran and 4th degree Knight whose Columbian accomplishments fill an entire page. Zimmerman is a member of St. Mary Magdalene Catholic Church in Simpsonville and has been a Knight for more than 40 years. He chaired Operation Hope for four record-setting years.

Zimmerman's council (#10819) won the Family Service Program Award. The Mauldin council (#8182) won three awards, including Church Service program and State Charity; their nominee, Jim Schwecke, was elected Knight of the Year.

The State Family of the Year is the Thomas and Fran Franzoni family of Christ Our King in Mt. Pleasant (council #9475), and the Golden Knight of the Year Award went to Joe Branton of Summerville (#6629). Spartanburg's Elizabeth Berg, a Special Olympian from council 9575 and the daughter of Glenn and Robin, was selected as the Youth of the Year.

Pawley's Island (#11028) won the Community Service Program Award and Charleston's 704 won the Council Service Program Award. Greenville (#13112) won both the Youth Service Program and the Catholicity Awards. Councils 5194 and 6629 had the best scrapbooks; 12554 and 6629 won Pulliam Awards in their respective divisions. The Gaffney council (#12995) won the Convention Attendance Award.

Best Councils were Greenville (#13112) in Division I and Spartanburg (#9575) in Division III.

Charles Maurer, a director of the Supreme Council, was the keynote speaker at the convention. He called the Knights "the greatest and most effective Catholic lay organization in the world." Maurer said that K of C membership worldwide is approaching 1.7 million; there are \$60 billion worth of Knights insurance policies in effect.

"Our principles have universal and timeless appeal, "Maurer said.

He told the full house at the Sheraton Hotel for the Saturday evening banquet that the first six K of C councils were established in Poland this year and that American Knights contributed \$10 million for Katrina Relief.

Bishop Baker, who concelebrated the convention mass with the state chaplain, Fr. James Parker, spoke about the characteristic of connectedness that binds the Church and the K of C together.

"The Knights of Columbus family is a perfect model of Catholicism," the Bishop of Charleston said. "With members like Bill Zimmerman as an example of true stewardship, we can say that nobody does it better than us."

United in Charity

At the annual Supreme Council meeting in Texas in 2004, Supreme Knight Carl A. Anderson introduced United in Charity, a general, unrestricted endowment to support and ensure the overall long-term charitable and philanthropic goals of the Order.

Every year, the Order receives special requests from the Catholic Church and organizations closely aligned with our mission of support for the Church.

Now, such requests must be met from the general funds of the Order or in combination with specific appeals, as for example the Gulf States Disaster Relief fund – and the demand at times far exceeds the supply. The funds from United in Charity would help support these vital endeavors in the future.

The initial response to United in Charity has been very positive. Since its inception the endowment has received almost \$2 million in donations. (Knights of Columbus Charities, Inc., has accomplished much in the last eight months, and approximately another \$5 million in contributions have already been directed to the Gulf States.) Nonetheless, it will take several years before it fulfills the Supreme Knight's vision of attaining a level capable of generating earnings to fund the Order's critical charitable objectives.

Living Wills Can Be Deadly

Please re-think your "living will"!! Living wills are <u>deceptive</u> because they utilize vague terms without defining them. For example, many assume an attending physician is the family doctor. In reality, it is the doctor assigned to your case and can be a total stranger. They are <u>dishonest</u> because they use terms everyday people may not understand. When someone reads "medically and surgically implanted tubes," they may not understand this can be as simple as an IV in the arm. Did you know that food and water are considered "extra-ordinary" means? You can be starved to death and it is all legal. A living will is <u>dangerous</u> because it can kill you against your will.

We strongly urge you to discard your Living Will and replace it with a Will to Live. Pro-Life Makes Headways.

A May 4 Harris poll found that support for abortion has dropped below 50% for the first time in 30 years. It also showed that 44% of Americans said they would support a law in their own state like South Dakota's, banning all abortions except to save the mother's life. An earlier survey found that 54% support limiting legal abortion to the extreme circumstances of rape, incest, and to save the life of the mother. This is encouraging and definitely shows that we are making an impact. Stay the course, Brothers! (Incidentally, we disagree with the rape, incest, etc. exception; **ALL** abortions are wrong. Pregnancy under these circumstances are a tragedy, but to abort/kill the innocent baby would be murder.)

Unborn Victims of Violence Act

Please ask every Council member to contact their state representative by phone or e-mail and urge him to pass the Unborn Victims of Violence Act of 2006 (S1084) with no amendments. We are closer than we ever have been since 1998 to passing the unborn victims bill, but time is quickly running out. The legislative session ends June 1. Opposition to the Unborn Victims of Violence bill is intense and well organized. Our House members are being flooded with calls and e-mails from opponents of the bill. From the State Retention Chairman

As we draw near the end of this fraternal year we each need to ask ourselves how well did we do with our council retention efforts. Have we made any improvement or are we in the same position we have always been where we are now confronted with dropping members because we haven't either heard from them or received their dues as yet?

How pro-active have we been this year in trying to implement the State Retention Program? How well do we understand it? Apparently there seems to have been some confusion in the process that was directed by Supreme in August 2003. And now we have further clarification of these guidelines. The following Memorandum from Supreme Secretary Robert J. Lane was sent to all Financial Secretaries on April 20, 2006. It is included herewith so each of you, whether in leadership positions or member within your councils will have this information on a first hand basis.

It is of particular importance to pay attention to paragraph 4 of the memorandum.

MEMORANDUM

DATE: APRIL 20, 2006

TO: FINANCIAL SECRETARIES FROM: SUPREME SECRETARY

RE: MEMBER WITHDRAWAL REQUEST PROCEDURES At the August 2003 meeting of the Board of Directors, approval was granted to modify the member withdrawal process. The new process requires a member to write to the Supreme Office requesting withdrawal. The revised procedures were announced in a memo from the Supreme Secretary dated September 16, 2003.

In the more than 30 months since this change has been in effect, the Supreme Office has experienced a variety of methods in which withdrawal requests have been received....form letters on council letterheads...check box options on billing notices...or generically-produced messages urging members to submit a withdrawal request. *These examples have not conformed with the intent of the revision and clearly appear to circumvent the published form #1845 retention procedures*. The intent of the 2003 revision was to obtain a letter signed by the member setting forth his intentions, in a communication to the Supreme Council Membership Records Department.

Effective immediately, the Supreme Office will no longer accept any form of withdrawal request other than a personal communication (not a form letter) signed by the member himself, not the council or his assembly. Your State Deputy continues to distribute reports of withdrawal transactions received in this office for use by the state council retention committee and district deputies to implement

and promote effective member retention.
